**Getting to the LSU Campus**

From I-10, take the Dalrymple exit. Turn right at the bottom of the ramp, and follow Dalrymple for 1/2 mile onto campus.

**Parking**

We have reserved a small parking lot (2 on the map) accessible from the Law center semi-circle drive. NOTE: The semi-circle drive is one-way and can only be accessed from Dalrymple Drive. The reserved lot holds only 50 vehicles. So, unless you arrive 30-45 minutes before the seminar begins, you may have to park in an overflow lot or garage. There is a parking garage (3 on the map) next door to the Law Center. The charge is \$1.50 per hour. There is a free overflow lot (4 on the map), that is a 5-7 minute walk to/from the Law Center. From Dalrymple Drive, turn onto W. Lakeshore Drive located next the International Culture Center (6 on the map). The overflow lot is designated as X-60 and is located behind the International Culture Center lot.
